ATTACHMENT 4 TO THE FACTORING AND COOPERATION AGREEMENT

SPECIFIC TERMS OF COOPERATION ON THE PARTNER WEBSITE

- **1.** The Partner Website must clearly specify the procedures for placing orders, making payments, deliveries and returns of Goods and refunds in case of returns of the Goods.
- **2.** If the Partner Website contains areas that require registration for access, the Partner shall provide REVO with test logins and passwords to access such areas.
- **3.** The Parties will cooperate to integrate the Mokka Platform into the Partner Website, each at its own expense.
- 4. In order to ensure that REVO's services are more accessible to the Customers of the Partner, the Partner shall transfer to REVO the Customers' personal data together with data about their purchases and payment methods selected, i.e. data regarding the Customer's activities on the Partner Website. The Partner shall ensure the lawfulness of the transfer of personal data of the Customers to REVO, in particular by informing the recipients of personal data in the privacy policy or information clauses on the personal data processing.
